With reference to SP Ukhrul order no. C-1 (G/P)/2023-SP (UKL)/9141 Dated 22/11/2023, a combined team of Ukhrul Police, 6th Bn. Manipur Rifles, Personnel of NAB, District Forest Department and Volunteers of CSOs led by Shri. Hopeson Chiphang, MPS, DSP/Ukhrul under the supervision of Superintendent of Police, Ukhrul, conducted illegal poppy destruction at Sihai Khullen on 23/11/2023 from 11:00 AM to 4:00 PM by the order of the Magistrate on Duty who furnished Attachment and Destruction order of illicit poppy cultivation in the said area U/S 48 ND & PS Act, 1985 (as amended). An area of about 8 (Eight) acres approximately was destroyed. It is expected to yield about 80 (Eighty) Kg, 10 Kg per acre of opium (Approx). None came forward to claim the ownership of the cultivated land. Thus, seized some poppy pods for inducing into evidence (if required) in the Court and for further legal action.

Hence, a suo-moto case under FIR No. 22(11)2023/UKL-PS U/S. 18 (b) ND & PS Act was registered for investigation.
