With reference to SP Ukhrul order no. C-1 (G/P)/2023-SP (UKL)/9141 Dated 22/11/2023, a combined team of Ukhrul Police, 6<sup>th</sup> Bn. Manipur Rifles, Personnel of NAB, District Forest Department and Volunteers of CSOs led by **Shri. H. Timothy, MPS, SDPO/Ukhrul** under the supervision of Superintendent of Police, Ukhrul, conducted illegal poppy destruction at Sihai Khunou on 23/11/2023 from 11:30 AM to 4:30 PM by the order of the Magistrate on Duty who furnished Attachment and Destruction order of illicit poppy cultivation in the said area U/S 48 ND & PS Act, 1985 (as amended). An area of about 20 (Twenty) acres approximately was destroyed. It is expected to yield about 200 (Two Hundred) Kg, 10 Kg per acre of opium (Approx). None came forward to claim the ownership of the cultivated land. Thus, seized some poppy pods for inducing into evidence (if required) in the Court and for further legal action.

Hence, a suo-moto case under **FIR No. 23(11)2023/UKL-PS U/S. 18 (b) ND & PS Act** was registered for investigation.
