

With reference to SP Ukhrol order no. C-1 (G/P)/2023-SP (UKL)/9476 Dated 02/12/2023, a combined team of Ukhrol Police, 6th Bn. Manipur Rifles, Personnel of NAB, District Forest Department and Volunteers of CSOs led by Shri. Timothy, MPS, SDPO/Ukhrol under the supervision of Superintendent of Police, Ukhrol, conducted illegal poppy destruction at Khamasom hill range on 05/12/2023 to 07/12/2023 from 11:00 AM to 2:00 PM by the order of the Magistrate on Duty who furnished Attachment and Destruction order of illicit poppy cultivation in the said area U/S 48 ND & PS Act, 1985 (as amended). An area of about 60 (sixty) acres approximately was destroyed. It is expected to yield about 600 (six hundred) Kg, 10 Kg per acre of opium (Approx). None came forward to claim the ownership of the cultivated land. Thus, seized some poppy pods for inducing into evidence (if required) in the Court and for further legal action.

Hence, a suo-moto case under **FIR No. 26(12)2023/UKL-PS U/S. 18 (b) ND & PS Act** was registered for investigation.
