I the undersigned would like to state few lines before your kind consideration and sympathetic action that on May 6th 2023 at around 1: 00 pm , Meitei organisation more than 1000 (One Thousand) suspected to be Arambai Tengol, Kangleipak Kanba Lup, Meitei Leepun attack my residence of Kamu Tampak Village, Kangpokpi District, PO, PS - Yairipok destroy and looted all my property

The cost of Property damaged and looted by the Meitei organization are given below.

- House destroy burnt down – 7 Lakhs
- Furniture items – 14 Lakhs
- Kitchen items – 5 Lakhs
- Clothing items -3 Lakhs
- Pets – 2 Lakhs

Total property damaged by Meitei organisation is worth around 31 Lakhs.

I therefore request you to look into the matter and file an FIR at your station for further necessary action.
