I the undersigned would like to state few lines for your kind consideration and sympathetic action that on May 6<sup>th</sup> 2023 at around 3: 00 pm , Meitei organisation numbering more than 1000 (One Thousand) suspected to be Arambai Tengol, Kangleipak Kanba Lup, Meitei Leepun attack my residence of Kamu Tampak Village, Kangpokpi District, PO,PS - Yairipok destroy and looted all my property.

The cost of Property damaged by the Meitei organization are given below.

1. House structure destroyed – 25 Lakhs
2. Furniture items – 20 Lakhs
3. Clothing items -10 Lakhs
4. Kitchen items – 15 Lakhs
5. Pets items – 5 Lakhs

Total property damaged by Meitei organisation is around 75(Seventy five) Lakhs.

I therefore request you to look into the matter and file an FIR at your station for further necessary action.
