burning down house and all the properties along with two wheeler and Licence  
Guns.

SIR,

I am to state that on the 5<sup>th</sup> May, 2023 at about 4:30 PM our locality  
and K. Nungmambi Village was under Mob attacked by a thousand of Miscreants  
belonging to valley base Meitei Community organisation called Arambai Tempol group.  
World Meitei Council and Meitei daupur with and instead to kill all my family  
members.

As a result many houses and properties were destroyed and burnt to ashes by the  
Mob and left over looted. Total loss of my properties would be about Rs-500000/-  
(Fifty Lakh) approximately, without any reason is highly condemnable and totally uncalled  
for booking of the culprits under appropriate section of the Indian Penal code.

I therefore pray that the culprits may be apprehended and befitting punishment  
may be accorded as per law of the land at the earliest.

I seek your help and kindly request you to register my FIR in the subject matter.  
Hope you will do the needful favourable at the earliest.
