Fact :- First information report on attempt to kill and maiming, looting and burning down house and all the properties.

I am to state that on the 6th May, 2023 at about 4:30 PM our locality and K. Nungmambi Village was under Mob attacked by a thousand of Meiteis belonging to valley base Meitei Community organisation called Atombai Tongol group, Ward Meitei Council and Meitei Desham with and intend to kill all my family members.

As a result many houses and properties were destroyed and burnt to ashes by the Mob and left over looted. Total loss of my properties would be about 200000/- (Twenty Lakh) approximately, without my reason is highly condemnable and totally uncalled for booking of the culprits under appropriate section of the Indian Penal Code.

I seek your help and kindly request you to register my FIR in the subject matter. Hope you will do the needful favourable of the riot.
