I am to state that on the 6th May, 2023 at about 4:30 Pm our locality and
K. Nungmambi Village was under Mob attacked by a thousand of Mischants belonging
to valley base Meitei Community organisation called Awankai Tengel group, World Meitei
Council and Meitei Karam with and intend to kill all my family members.

As a result many houses and properties was destroyed and burnt to ashes by the
Mob and left over looted. Total losses of my properties would be about 2000000/-
(Twenty Lakhs) approximately, without my reason is highly condemnable and totally
uncalled for booking of the culprits under appropriate section of the Indian Penal
Code.

I seek your help and kindly request you to register my FIR in the subject
matter. Hope you will do the needful favourable at the earliest.
