I am to state that on the 5th May, 2023 at about 4:30pm

and intend to kill all my family members.

As a result many houses and properties were
destroyed and burnt to ashes by the mob and
left over looted. Total losses of my properties
would be about Rs 1500000/- (Fifteen Lakhs)
approximately, without any reason is highly
condemnable and totally uncalled for booking
of the culprits under appropriate section of the
Indian Penal Code

I therefore pray that the culprits may be apprehended
and befitting punishment may be awarded as per law
of the land at the earliest.

I seek your help and kindly request you to register
my FIR in the subject matter
