Sir,

I am to state that on the 4th May, 2023 at about 1:00 pm
our locality and Kamuching village was under Mob
attacked by a thousand of Miscreants to Valley base
Meetei community organisation called Ahombsai
Tengol group, world Meetei council and Meetei
Jeipien with and intend to kill all my family
members.

As a result many houses and properties were
destroyed and burnt to ashes by the mob and left
over looted. Total losses of my properties would
be about Rs 1300000/- (Thirteen Lakhs) approximately,
without any reason is highly condemnable and
totally uncalled for booking of the culprits
under appropriate section of The Indian Penal
Code.

I, therefore pray that the culprits may be
apprehended and befitting punishment may be
awarded as per law of the land at the earliest.
I seek your help and kindly request you to register
my FIR in the subject matter.
