Sir,

I have the honour to report that on the 4th May 2023 at around 7:00 AM. Some unknown miscreants suspected to be a volunteers of Akambai Tergot, Miteikheepur, Kangleipok Karba Lup (KKL) numbering about 1000 persons carrying sophisticated weapons like AK, SLR, INSAS forcefully entered our village of Kamuching, Island Sub-Division, Mapah Police Station, Kangpokpi District.

After vandalising and looting all the moveable properties including furniture, Jewellery, Utensils, clothes, electricals and electronic items, Heavy duty vehicles, food and grains etc. They burnt down my houses to ashes leaving us homeless. The approximate value of lost property is calculated at about Rs. 1,00,00,00/- (One Crore)

It is therefore requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
