Subject – Complaint/ Report on attempt to murder, arson attack, crimes of vandalism, looting of properties and discrimination of Scheduled Tribes.

Dear Sir/Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

- That, I am a Scheduled Tribe belonging to the Thadou/Kuki Tribe, which is a recognized Tribe under the Constitution of India. And, I am a permanent resident of B. Seizaland Village, P.O. Yairipok, P.S. Maphou, District- Kangpokpi, Manipur.
- That, on the 5th May, 2023, at about 3:00 PM, a huge contingent of armed radical Meitei/Meeteis suspected members of Arambai Tenggol and Meitei Leepun headed by the Manipur State forces like the Manipur Police Commando and the Indian Reserved Battalion (IRB) attacked our village and in the process, they have looted, vandalized and torched my house.
- 3. That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO", "HAO HATLO"; etc. while they were carrying out criminal activities. It seems to me that all these has taken place at the instance of Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that no harm could be done to them.
- 4. That, at the time of attack we somehow managed to escape to save our lives under the compelling circumstances and thus could not take our belongings including important documents like Adhar Card, ATM Card, PAN Card, Educational certificates, etc. apart from other tangible materials. A list of our properties looted/destroyed/burnt is attached here under with estimated costs. The Total loss suffered is estimated to be about Rs 1,750,000/-(Seventeen lakhs fifty thousand rupees)

5. That, I am filing this information lately because I was at different places to save my life and now I am settled at ECA Salbung Relief Center.
