I, the undersigned would like to bring forth to your knowledge and report that my residence (owned/Rebtal) at Kamutampak village, PO&PS Andro Districtg Kangpokpi Manipur and that because of the ethnic conflict prevalent in the state, some unknown well armed miscreant belonging to the meetei/meitei community on being targetging our village and its villagers to gutted down our houses and bodily harm the people to the extgent of death, with no means of defence and security from the state Government leaving us hapless on being feared for our life dcserted our village on 6th May at 11:30 am leaving behind all our assets and home a total estimated at an amount of Rs 17,55,000/- was left behind at the mercy of the above mentioned well armed meetei/meitei miscreant and now currently resides at Dorcas Relief Centre..

Therefore, I kindly request you to please act in this matter and come up with positive solution.
