Sir,

I am to bring to your kind notice that i am a Schedule tribe (Kuki/ Zo) and a resident of Kamu Tampak Village, Kangpokpi District

That on the 6th May 2023 at 11:30 am, my above said residence (owned/ rented) was attacked, destroyed and looted and burned by a groups of Meiteis/ meeteis radicals.

These criminals broke, open my gate(s) destroyed and looted every valuable property from my "own/rented" house and premises worth Rs. 3,680,000/- (approx.) and they burnt down all the remaining things.

That, while carrying out their above said criminal activities, the said Meitei radicals groups were shouting anti tribal's slogans like "HAO HATLO", "KUKI HATLO", "KANGLEIPAK YAI PHARE" etc. Hence, the same can be taken as an insult on me and my family for being a tribal's.

I, Therefore, request you to kindly take strong action against the the perpetrators by registering an FIR/ Zero FIR under relevant sections of the statutes of our country.
