With due respect, I am to bring to your kind notice that on the 6th May, 2023 at around 01:30 pm my residence located at Heiroland village, District Kangpokpi PO&PS Andro Manipur and that because of the ethnic conflict prevalent in the state, some unknown well armed miscreant belonging to the meitei/meitei community on being targeting our village and its villagers to gutted down our houses and bodily harm the people to the extent of death, with no means of defence and security from the state Government leaving us helpless on being feared for our life deserted our village leaving behind all our assets and home a total estimated at an amount of Rs 1188000/- was left behind at the mercy of the above mentioned well arm Meitei miscreants and now currently resides at Dorcas Relief Centre..

Therefore, I kindly request you to please take action in this matter and come up positive solution at the earliest
