P.O.&P.S. Maphou District Kangpokpi Manipur,  
belonging to KUKI tribe/community, recognized under the constitution of India.  
Thereby, I am entitled to the protection provided under The Prevention of Scheduled caste/  
Scheduled Tribe Atrocities Act.

Due, to the ethnic conflict prevalent in the State, some unknown well-armed radicals belonging to the Meetei/Meitei community, aided by State's Forces posted at various Valley-based Police outpost chanting anti Tribal Slogans on the 5<sup>th</sup> MAY 12:30pm looted, vandalized, burnt/gutted my shop and all what is within the shop and its premise, owned and under my proprietorship, a total estimated amount of Rs 5 lakhs was lost due to the illegal activities of the said armed-radical groups.

I, therefore kindly request you to please take action in this matter and come up with positive solution.
