I, the undersigned would like to bring forth to your knowledge and report that my residence (owned/Rental) at Heiroland village, PO&PS Andro District Kangpokpi Manipur and that because of the ethnic conflict prevalent in the state, some unknown well armed miscreant belonging to the Meetei/Meitei community on being targeting their village and its villagers to gutted down their houses and bodily harm the people to the extent of death, with no means of defense and security from the state's Government leaving their hapless, on being feared for their life deserted their village on the above mentioned DO leaving behind all their assets and home, a total estimated at an amount of Rs 615000/- was left behind at the mercy of the above mentioned well armed Meetei/Meitei miscreant and now currently resides at Dorcas Relief centre.

Therefore, I kindly request you to please act in this matter and come up with positive solution.
