Today i.e. 20/07/2023 at 04:00 pm Police teams led by IGP Zone - I , Shri Themthing Ngasangva. IPS, the SP/IE, Shri Ksh. Shivakanta Singh, IPS, including Rapid Action Force have travel along Imphal Ngariyan road for Nongpok Sekmai, Thoubal District. On arriving at Yairipok Angtha Village area along Imphal Ngariyan road, a large number of unruly mob including men and women holding dangerous weapons like sticks, iron rod and catapults etc. have blocked the police teams at Yairipok Angtha. In order to prevent the unruly mob, Police teams and Rapid Action Force including teams of Andro PS have expanded anti Riots equipment like mob bomb, tear gas shell etc. After dispersing the unruly mob the Police teams further advance towards Yairipok side. However, the unruly mob again blocked the Police teams near Yairipok Tulihal. The unruly mob also dug the Imphal Ngariyan Road near the crossing of Inter Village road (IVR) of Tulihal Village by using two Excavator (JCB). The Police teams expanded anti Riots equipment like mob bombs, tear gas shell etc. at this area also for controlling the unruly mob. However the unruly mob continues their activities till late night.

Hence, a Sou Motto case under case FIR No.329 (07)2023 APS u/s 147/148/149/353/431/34 IPC is registered for investigation.
