MOLNOM, P.O./P.S. MAPHOUDAM, KANGPORA District, Manipur-795 149

2. That, at about 11:00 am/pm on the 30 th May 2023, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along with various state forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked our villages and in the process, they have looted, vandalized and torched my house.

3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs 25, 60000

4. Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at KCC Church Relief Camp, Wibing

In the given circumstances, I humbly pray you to kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
