Sharongphai , Kangpokpi District, Manipur owned by owned by Mizoram Presbyterian church Synod Manipur area, aka Tangphai Presbyterian church was attacked, destroyed. looted and burned by a group of Meeteis/ Meiteis.

These criminal broke open the gate(s), destroyed and looted every valuable properties from the premises which is worth Rs. 30 Lakhs (approx.) and they burnt down all the remaining things.

Therefore, with utmost respect I Request you to take strong action against the perpetrators by registering an FIR under relevant section of the Indian Penal code.
