Subject – Report on attempt to murder, crimes of vandalism, looting and burning of properties.

Dear Madam,

With reference to the above cited subject, I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo), resident and chief of B. Gamnom Village under Maphou Police Station, Kangpokpi District.

That, on the 5<sup>th</sup> May, 2023 at 3 PM my above said village was attacked, 31 houses were destroyed, looted and completely burned by a group of Meeitei/Meitei radicals.

These criminals indiscriminately fired automatic weapons, forcefully entered the village, destroyed and looted every valuable property from each houses worth Rupees 22,550,000 (Approx) and they burnt down all the remaining things.

That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans like- "KANGLEIPAK YAIPHARE", "KUKI HATLO"; "HAO HATLO"; etc.

I, therefore, request you to kindly registered my case and take a stern action against the perpetrators by registering an FIR/Zero FIR under relevant provisions of the law of our country.
