Subject: Report of on vandalism, looting and burning of properties (movable/immovable).

Sir,

I, am to bring to your notice that 6th May 2023 at around 4:00 pm unknown mobs from the Meitei Community armed with deadly sophisticated weapons viz. Automatic guns like AK Rifles, SLR, machete/sword, iron rods, etc. Came and forcefully vandalized and looted our houses thereby burning our houses and sericulture rearing materials, two wheeler vehicle, the description of which is detailed hereunder:- (1) Immovable Property – Semi-Pucca residential building (2) Movable property- (i) All the domestic goods inside the house including important documents and sericulture rearing materials. (ii) A motorbike bearing No. MN01L9857. That the estimated value of both the movable and immovable property destroyed, looted and burnt is estimated to be worth approximately Rs. 25, 00,000/- (Rupees Twenty Five Lakhs) only

Therefore, with utmost respect I Request you to take strong action against the perpetrators by registering an FIR under relevant section of the Indian Penal code.
