I, am to bring to your notice that I am a scheduled Tribe(Kuki/Zo) and a resident of Heirokland Village, Kangpokpi District PO/PS - Andro.

That on the 6<sup>th</sup> of may 2023 at 11:30 am/pm, my above said residence (Owned/Rented) was attacked, destroyed,looted and burned by a group of Meetei/Meitei radicals.

These criminals broke/Open my gate(s), destroyed and looted every valuable property from my "Owned/Rental" house and premises worth Rupees 3442000/- (Approx) and they burnt down all the remaining things.

That while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans like "HAO HATLO","KUKI HATLO"," KANGLEIPAK YAIPHARE" , etc. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/ZERO FIR under relevant sections of the statutes of our country.
