That while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans like "HAO HATLO"," KUKI HATLO"," KANGLEIPAK YAIPHARE", etc. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/ZERO FIR under relevant sections of the statutes of our country.
