I, the undersigned would like to bring forth to your knowledge and report that on 11/06/2023, the complainant reported to OC/ WPS-CCP in written stating that because of the ethnic conflict prevalent in the state, some unknown well armed miscreant belonging to the Meetei/Meitei community on being targeting their Village and its villagers to gutted down their houses and bodily harm the people to the extent of death, with no means of defence and security from the state's Government leaving them hapless, on being feared for our life, deserted their village on 6th May 2023 at 1:30 pm, leaving behind all their assets and home , a total estimated at an amount of Rs. 2039000/- was left behind at the mercy of the above mentioned well armed meetei/Meitei miscreant and now currently resides at Dorcas relief Centre

Therefore, I kindly request you to please act in this matter and come up with positive solution.
