Sir,

I, am to bring to your notice that I am a schedule tribe(Kuki/Zo) and a resident of Kamu tangnom Village, Kangpokpi District.

That on the 6th of may 2023 at 11:30 am her residence located at Kamu Tampak Village, Kangpokpi District was attacked, destroyed, looted and burned by a group of Meeteis/ Meiteis.

These criminals broke ,open the gate(s), destroyed and looted every valuable property from her House and premises worth Rs. 9210000/- (approx.) and they burnt down all the remaining things.

That while carrying out their above said criminals activities, the said Meitei radical groups were shouting ani tribal slogan like “ HAO HATLO”, “ KUKI HATLO”, KANGLEIPAK YAI PHARE”, etc. Hence the same can be taken as an insult on me and my family for being a tribal.

I, therefore request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of the statutes of our country.
