These criminals broke/open my gate(s), destroyed and looted every valuable property from my "Owned / Rental" House, and premises worth Rupees... \$5,30,000...(Approx.) and they burnt down all the remaining things.

That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti- tribal slogans like- "HAO HATLO", "KUKI HATLO", "KANGLEIPAK YAI PHARE", etc. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/ Zero FIR under relevant sections of the statutes of our country.
