With due respect, I have the honour to state that, on the 29<sup>th</sup> May 2023 at around 3:00 PM, unknown miscreants numbering more than 200 people from the Meitei community suspected to be members of Arambai Tenngol and other Extremist volunteers by holding various deadly weapons including Automatic Rifles attack our village i.e. Saichang Village, Kangpokpi District. They robbed, demolished and burnt down my house along with the following properties and important documents etc. The details are as under:

The Total amount of destroyed properties are estimated at Rs 50,00,000/- (Rupees Fifty lakhs only). The incident could not be reported immediately due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.
