Molnom Village, Saikul Sub-division, Kangpokpi, District, Manipur which comprises of 29 houses, Church and public properties. As we were completely outnumbered and helpless we fled and hid in dense forest to save our life. They had destroyed locked doors, looted every pieces of our properties, burnt down houses including mine. All the remaining valuable properties were burn to ashes.

In this regard an FIR report for all my villager were already filed, however as some of my villager list were left out that I the undersigned request your kind entry of my leftover villagers for the same.
