4. Sofa set, furniture worth Rs 70000/-
5. Steel Almirah 3 drawer 2 worth Rs 90000/-
6. Approximate Value of One House is Rs. 550000/-
7. Miscellaneous Household items worth Rs. 2,30000/-

Total approximate value of property lost during arson, loot and destruction was Rs. 1,260,000/-
