4. Electronic items, TV, Inverter, etc. worth Rs. 80000/-
5. Refrigerator, washing machines, filter worth Rs. 95000/-
6. Approximate Value of One House is Rs. 850000/-
7. Miscellaneous Household Items worth Rs 350000/-

Total approximate value of property lost during arson, loot and destruction was Rs. 1690,000/- Sixteen lakhs Ninety thousand only.
