The list of lost properties are mentioned below:

1. Furniture Sofa set - 2 nos worth Rs. 75000/-
2. Utensils and clothes worth Rs. 95000/-
3. Bed 4 nos @ Rs. 30000/- worth Rs. 120000/-
4. Steel Almirah 3 nos @ Rs. 30000/- worth Rs. 90000/-
5. Land paddy field 3-pus @ Rs. 3000000/- worth Rs. 9000000/-
6. Approximate Value of One House is Rs. 1500000/- fifteen lakhs.
7. Miscellaneous Household Items worth Rs. 45000/-

Total approximate value of property lost during arson, loot and destruction was Rs. 11,330,000/- one crore thirteen lakhs and thirty thousand.
