1. 60 Bags Rice + 1 bicycle worth Rs 12,000/-
2. 2 Beds + 2 Almirah + 1 Bed box worth Rs 90,000/-
3. Cooking gas set + 1 Sofa set worth Rs 55,000/-
4. 1 acre Paddy field + 2 nos Cow worth Rs 10,45,000/-
5. 1 pet dogs + kitchen items etc. worth Rs 65,000/-
6. Approximate Value of One House is Rs. 3,00,000/-
7. Miscellaneous Household items worth Rs. 85,000/-

Total approximate value of property lost during arson, loot and destruction was Rs. 17,12,000/-
(Seventeen lakhs Twelve Thousand) only.
