Kangpokpi Dist. during arson, loot and destruction of the above mentioned village on 01.5/5/2023 at around 11:30 Am - 3 p.m by Meetei Activist, Meetei Leepun and Arambai Tenggol. The List of lost properties are mentioned below:

1. 3 acre Paddy field + 5. acre hngkho worth Rs 1,01,80,000/-
2. Rice 100 Bags + Rice mill worth Rs 2,50,000/-
3. 1 Alto car + 7 Beds + 3 Almirah worth Rs 7,20,000/-
4. Fridge + W. Machine + kitchen Items worth Rs 2,00,000/-
5. 2. Sofa set + 5. Buffaloes + 5 Pigs + 8 cows worth Rs 7,40,000/-
6. Approximate Value of One House is Rs. 25,00,000/-
7. Miscellaneous Household items worth Rs. 2,50,000/-

Total approximate value of property lost during arson, loot and destruction was Rs. 1,48,40,000/-  
(One crore forty eight lakhs forty thousand) only.
