I herewith submit this complaint for losses incurred on my property in Bongbal Kholen vill. Island block, Kangpokpi Dist during arson, loot and destruction of the above mentioned village on Dt 5/5/2023 at around 11.30 AM - 3 P.M by Meetei Activist, Meetei Leepun and Arambai Tenggol. The List of lost properties are mentioned below:

1. 1 acre Paddy field + 40 Rice Bagworth Rs 5,40,000/-
2. 3 Beds + 1 Sofa set + 2 Almirah worth Rs 1,18,000/-
3. Cooking gas set + Kitchen Items worth Rs 60,000/-
4. Mattresses, Blankets and Boxes worth Rs 75,000/-
5. 50 nos of ducks and 40 nos hens worth Rs 55,000/-
6. Approximate Value of One House is Rs. 6.5 Laes.
7. Miscellaneous Household items worth Rs. 70,000/-

Total approximate value of property lost during arson, loot and destruction was Rs. 15,68,000/-
(Fifteen lakhs sixty eight thousand) only.
