Island block Kangpokpi Dist. during arson, loot and destruction of the above mentioned village on dt 5/5/2023 at around 11.30 AM - 3 pm by Meetei Activist, Meetei Leepun and Arambai Tenggol. The List of lost properties are mentioned below:

1. Rice 60 bags + 2 bicycle worth Rs 80,000/-
2. 3 beds + 3 Ahmirah + sofa set worth Rs 1,40,000/-
3. Fridge + w. Machine + flat TV worth Rs 76,000/-
4. Cooking gas + kitchen items worth Rs 1,40,000/-
5. 2 pet dogs + 3 pigs + 4 cow + 17 Hens worth Rs 1,28,000/-
6. Approximate Value of One House is Rs. 10,50,000/-
7. Miscellaneous Household items worth Rs. 1,30,000/-

Total approximate value of property lost during arson, loot and destruction was Rs. 17,31,000/-
(Seventeen lacs thirty one thousand)
