Sir,

With due respect, I the undersigned would like to lay down few lines before you for your kind consideration and necessary action.

That, I am serving in Indian Reserve Battalion, 4th Bn under Hav. No. 8443, K. Thangkhoisei Kipgen and presently posted at SBI Bank duty at Kangpokpi Branch.

That, On the 5th May, 2023 at @ 11AM, unknown miscreants belonging to Meitei community, numbering more than 500 people suspected to be members of ArambaiTengol, MeeteiLeepun and others have attacked our village i.e Bongbal Kholen by holding deadly weapons including automatic rifles and others sharp weapon. The miscreants have ransacked and burnt down my residential house and all properties like furniture, kitchen items, clothing and garments, important documents, electronic items, grains and rice. Further the Meitei Miscreants looted my domesticated animals such as 10(Ten) Buffaloes and 22(Twenty Two) Cows from the respective shed. The estimated value of properties lost/looted, ransacked and burnt down by the miscreants is estimated to be Rs. 52,00,000/- (Fifty Two lakhs only).

I could not report in my concern Police Station as well in time due to the prevailing law and order situation.

I, therefore request you to kindly take necessary action in this regard for which, I shall remain thankful to you.
