Sir,

I am constrained to inform you that on the 5th May, 2023 at about 4:00 – 5:30 p.m, a group of mobs belonging to the Meeitei Community armed with Automatic Rifles, sharp weapons etc, forcefully entered our village and after looting, vandalising and destruction of my property, completely burnt down my Kaccha house at Kamuching Village, Kangpokpi District, Manipur.
