Subject : Report on looting, vandalism and arson of house.

Sir,

I am constrained to inform you that on the 5th May, 2023 at about 4:00 – 5:30 p.m, a group of mobs belonging to the Meeitei Community armed with Automatic Rifles, sharp weapons etc., forcefully entered our village and after looting, vandalising and destruction of my property, completely burnt down my Pucca house at Kamuching Village, Kangpokpi District, Manipur.

The movable and immovable properties that have been burnt are as given below :

(vi) kacha House : valued at Rs. 2 Lakhs

(vii) Household Items/Properties :worth Rs. 2 Lakhs

(viii) Rice Stack : worth about Rs. 20,000/-

(ix) Buffalo (1 Nos.) : worth about Rs. 10,000/-

(x) activa (two Wheeler) : worth about Rs. 30000/-
