I hereby inform that on 05/05/2023 at around 6 am during the Ethnic problem, some unknown mob broke into the rented house of Shri TS Hemkhomang Haokip, Age-50 yrs, S/o (L) TS Semkhothang Haokip at Haokip Veng, Imphal, where I am a tenant and entered forcefully into the house. The unknown mob destroyed the properties, took away the valuable properties and finally burnt down all the remaining properties and the house. Due to the present prevailing Ethnic problem in the state, the matter could not be reported in time.

So, I therefore, request you to lodge an FIR into the matter at the earliest.
