Sir,

I am Dr. (Mrs.) MOICHI SAKA, wife of Mr. SHONNGAM SAKA, presently working as a Medical Officer in Machi PHC, Government of Manipur, Tengnoupal District, Manipur. I belong to Khoibu Naga community of the Maring Naga tribe in Tengnoupal District, Manipur.

On the night of **May 3, 2023 at 6:15 PM** I went to New Lambulane, New Chekon, Imphal East, to see (pay a visit) one of my ailing Grandmas who is 80 years old. While talking with her, suddenly a group of unruly mobs came inside the colony and started ransacking and damaging every bike, scooters and vehicles parked at roadside. My medical VAN bearing No. **MN01AK9418** which was parked near the Entrance Gate was completely burned down to ashes. Next day morning, Police Officers came and saw the damage and took report of the damages.



Medical services in the hilly regions requires Van without which it is very difficult to provide medical services. It will be very hard and difficult for me to continue my profession without a Van.


I, therefore, request you kindly register a FIR under any relevant sections of the Indian Penal Code and initiate for redressal of my difficulty in the earliest. With kind regards!


