Sir,

With due respect I beg to state that on 10/5/2023 at about 7 P.M. some unknown miscreants numbering about 90/100 suspected to be activists of Meitei Arambai/Meitei Leepun etc came to my rented house at New Chekon, near traffic point, Imphal East District ^{owned by L.M. Khante} and vandalized everything in my house and damaged furniture worth about Rs. 5(five) lakh, TV, fridge and other electronics items worth about Rs. 3(three) lakh, Kitchen wares worth about Rs. 1(one) lakh and other household items including clothing worth about Rs. 5(five) lakh. The miscreants had also taken away and looted many household goods worth about 5(five) lakh. I cannot report the matter in time due to prevailing law & order situation in Manipur.

I, therefore, request you to kindly take up necessary legal action in this regard.




