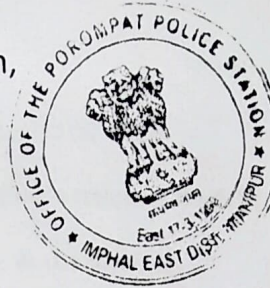

I, the undersigned have the honour to report that, on dated 03-05-2023, at around 6:00 PM, a group of unknown miscreants from Meitei community, suspected to be members of Arambai Tenngol, Kangleipak Kanba Lup and Meetei Leepun numbering more than 500 (Five hundred) people holding deadly weapons attacked at my rented residence at New Lambulane 1st Street, New Checkon (Mr. Paolet Touthang – House Owner). I along with my family had escaped from our house in fear of them and the miscreants then looted all my properties amounting to Rs. 5,00,000/- (Five Lakhs only) approx. and also destroyed all the properties left behind.

Therefore, I request you to lodge an FIR in connection with this incident.

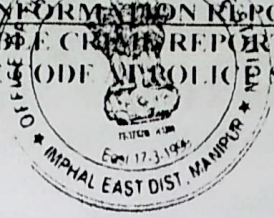
