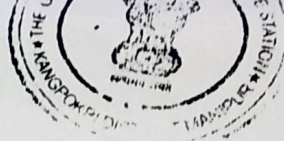

Sir,

With due respect, I have the honour to state few lines before you for your kind consideration and necessary action.

That on the 4th May 2023 at around 7:00 PM, unknown miscreants suspected to be members of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun numbering about 1000 people holding deadly weapons attacked my residential building which is four storey at Chassad-Avenue (Nongpok Ingkhol), Imphal East. The miscreants have looted all the household properties in the building and finally gutted down the four storey building into ashes. The approximate value of lost property is estimated to be about Rs. 5,00,00,000/- (Five Crore).

I could not report the incident to the concerned Police Station in time due to the prevailing law and order situation in the state.

I therefore kindly request your good office to kindly take up necessary action in this regard.




