With due respect and humble submission, I, Nemkhohoi Haokip (35) W/O M. Jamkhotinsat Haokip of Chassad, Ukhrul District, Manipur residing as tenant at house of Mr. Thangjahao Haokip of Chassad Avenue, Imphal East would like to state that on 04-05-2023 at around 5:00 pm, unknown miscreants suspected to be Arambai Tengol, Meitei Leepun, Kangleipak Kanba Lup numbering about 500 holding deadly weapons attacked Chassad Avenue, Imphal East. In the incident, the miscreants vandalized all my household properties including the house and looted all the household properties, important files and documents and a cash of Rs 4 lakhs.

The approximate value of loss/destroyed and looted properties is estimated to be about Rs.15,00,000/- (Rupees fifteen Lakhs) only.

I could not report in my concern police station as well in time due to the prevailing law and order situation.

I therefore kindly request you to take necessary action in this regard.

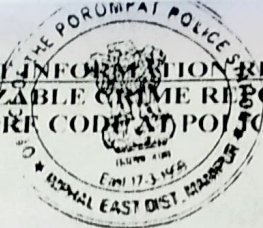
