The miscreants have destroyed and burnt down my DIGITAL PIANO "CASINO PIANO AP-650M KP44" which cost Rs. 1,22,000/- (One lakh Twenty two thousand only) which was inside the Church premises.

So, I will not be able to pay my EMI Loan on time in such a situation and I will not be reliable for any penalty from the Bank. Furthermore, missing my EMI payment may not impact my CIBIL score and ability to avail Loans in future. I have also enclosed a copy of my piano TAX INVOICE and LOAN APPROVAL LETTER for proof.
