Sir,

With due respect, I the undersigned would like to make a report to your good office about an attempt to murder on 4th May 2023 at around 7:00 pm by some valley based organisations suspected to be volunteers of Arambam Tenggol or Kangleipak Kanbalup (KKL) while I was inside my room at JNIMS P.O & P.S Porompat District Imphal East.

At the very onset, I would like to draw a few line for your information that in the intervening day a mob (Meitei) entered our girls hostel at around 7pm and they were searching for any kuki/Zo people residing there while shouting anti tribal slogans like "hao hatlo/kuki hatlo". Fortunately I managed to escape from these criminals who tried to kill/burn me alive.

I therefore request you to take up necessary legal action regarding the incident.
