Sir,

I have the honour to inform you that on 6th May, 2023 at around 12:00 pm a suspected volunteers of Arambai Tenggol, Meitei Leepun and Kangleipak Kanba Lup attacked my rented house at New Lambulane, 3rd Street, Imphal East with sophisticated/automatic weapons such as AK-47, SLR with the intention to kill us. During the course of attack, one of my sister (Nengboi Haokip) got fractures on both her legs while trying to save her life from the inhumane act of the attackers. They have stolen all my valuable household properties and damaged my private car Datsun Redigo (white in colour) bearing registration no. MN06LB-0043.

The total approximate worth of loss/damaged properties is 40,00,000/- (Forty Lakhs). I Therefore, request you to kindly take up a necessary legal action.
