The unknown miscreants numbering about 500 people suspected to be the members of Harambai Tengol, Kangkipak Kanka Lup, Meitei Deepan and Meitei St Demand Committee pelted stones and damaged all the house windows afterwards they forcefully entered our house and damaged our properties and looted all our precious belongings and later burnt down our house in the incidence my house was also burnt down and so many other valuable electronic materials were also looted away and damaged properties worth around 35 lakhs.
