- ③ Refrigerator worth Rs. 23,000/-
- ④ 2 (two) nos of Cofed Almirah worth Rs. 34,000/-
- ⑤ 2 (two) nos of Wender Almirah worth Rs. 1,20,000/-
- ⑥ gas stove worth Rs. 4,000/-
- ⑦ cylinder 4 worth Rs. 8,000/-
- ⑧ traditional shaw worth Rs. 80,000/-
- ⑨ cash Rs. 10,00,000
- ⑩ Utensil worth Rs. 30,000
- ⑪ Gold Ring and Necklace worth Rs. 5,00,000
- ⑫ Furniture (table, chair sofa) worth Rs. 1,30,000

The total value of properties lost at my house is about 19,76,000. (Nineteen lac Seventy Six thousand)

I therefore urge you to take further necessary action at the earliest as per Law of the land.


